This deed of public charitable trust executed on this 20-JUNE day of 2017 between

Ramanand Singh S/o Late Mahesh Singh, Resident of Village Sahijana, P.O. & P.S. Garhwa, Dist. Garhwa, Jharkhand, herein after the 'Founder' (which expression shall, unless excluded by or repugnant to the context, be deemed to include his executors, administrators and representative) of the one part, Adahar No. 2840 5873 8460

Hereinafter jointly referred to as 'trustees' (which expression shall, unless excluded by or repugnant to the context, be deemed to include the trustee or trustees for the time being of these presents and their successors in office) of the other part.

Whereas the Founder is desirous of establishing a trust for Public Charitable Objects. And whereas the trustees have, at the request of the Founder, agreed to act as the first trustees of these presents as testified by their being parties to and executing these presents.

And whereas it is necessary to declare the objects and terms of the public charitable trust, being constituted under these presents:

Now this indenture witnesseth as follows:

- 1. That, in order to effectuate his aforesaid desire, these, the founder has set apart and handed over to the trustees out of his inherited property, a sum of Rs. 1,00,000/- (Rupees One Lacs only) hereinafter called the 'Trust Fund' which expression shall include cash and any other property or investments of the kind whatsoever into which the same or any thereof might be converted, invested or varied from time to time or which may be acquired by the trustees or may come to their hands by virtue of these presents or by operation of law or otherwise howsoever in relation to these presents), and the trustees shall hold and stand possessed of the same upon the trust subject to the powers, provisions, agreements and declarations hereinafter contained.
- 2. That the name of the trust shall be "ADHIKARI DEVI JAN SEWA TRUST" and its office shall, for the presents, be situate at Sahijana, District Garhwa (Jharkhand) and/or at such other places as the trustees may decide from time to time.
- 3. That the objects which this is established are:
 - (a) To establish, develop, maintain and grant aid in cash or in kind to schools, colleges, nursing institutions, B. Ed. College, hospital, Medical Institution, Vocational Course Programme, Training school/college for P.T.I, Education etc, dispensaries, maternity homes, child welfare, Rehabilitation of Old age home and/or such other similar charitable institutions in India for the benefit and use of the general public.
 - (b) To establish, run, support and grant aid or other financial assistance to schools, colleges, libraries, reading room, universities, laboratories, research and other institutions of the kind like nature in India, for use of the students and the staff

- and also for the development and advancement of education of knowledge among the public in general.
- (c) To establish, maintain and run studentships, scholarships and render other kind of aid to students including supply of books, stipends, medals, and other incentives to study, without distinction as to caste colour, race creed or sex.
- (d) To promote, establish, support, maintain or grant aid to institution for the promotion of science, literature, music, drama and fine arts, for the preservation of historical monuments and for the research and other institution in India, having similar objects for the benefit of the public in general.
- (e) To establish, maintain or grant aid for the establishment and /or maintenance of dharamshalas and rest house, for use by public in general.
- (f) To establish, maintain or grants aid to homes for aged, orphanages or other establishment for the relief and help to poor, needy and destitute people, orphans, widows and aged persons.
- (g) To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help.
- (h) To grant relief and assistance to the needy victims during natural calamities such as famine, earth quake, flood, fire, pestilence, etc. and to give donations and other assistance to institutions, establishments or persons engaged in such relief work.
- (i) To grant aid or render assistance to other public charitable trusts or institutions,

4. That the Trust Fund shall not be applied for any purpose other than specified in Para 3 hereinabove.

5. That the Trust Fund may be augmented by the income from the initial fund and also by donations and other contributions from time to time.

6. That the trustee shall always maintain proper accounts of the Trust, which shall be kept at the office of the trust.

7. That for the furtherance of the objects of the trust, the trustees shall have the following powers:

- (a) To accept any donation, contribution, grant or subscription in cash or kind, from any person(s), body of persons or trust/society, Corporate Sector, with or without conditions.
- (b) To apply the whole or any part of the income of the trust, or the trust fund or accumulations thereto, to any one or more of the objects of the trust, as the trustees may, in their discretion, deem fit from time to time.
- (c) To convert and deal with the trust property and/or any investment for the time being.
